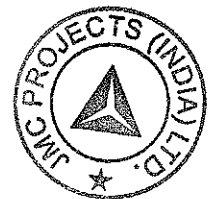
- Two orders totalling Rs.236 crores for construction of educational institutes in Andhra Pradesh
