This has reference to our letter dated March 23, 2020 informing about closure of operations at Company's various offices and project sites across the country.

We wish to inform you that in light of the Ministry of Home Affairs ("MHA") Order dated April 15, 2020 and after obtaining necessary permissions/approvals as required, operations at Company's project sites in some parts of the country have been partially resumed with effect from April 21, 2020. For the remaining project sites in the country, the Company has either sought or is in the process of seeking permissions/approvals from relevant authorities and the Company expects to resume operations gradually upon receiving such permissions/approvals.

Considering the prevailing uncertainties, it is difficult at this point in time to ascertain the impact of disruption in our operations caused by COVID-19 pandemic.
