Dear Sir / Madam,

Please refer our letter dated 3rd July, 2019 about intimation regarding entering into definitive agreements by the Company and Techno Electric and Engineering Company Limited ("Techno", a joint-venture partner) with CLP India Private Limited (now known as **Apraava Energy Private Limited**) ("**Buyer / Apraava**") to sell their respective stakes in Kohima-Mariani Transmission Limited ("KMTL") to the Buyer, subject to receipt of requisite approvals and compliance of conditions precedent.

The Company held 74% equity stake and Techno held the remaining 26% equity stake in KMTL.

We are now pleased to inform that the Company and Techno today successfully completed transfer of 49% stake (23% by the Company and 26% by Techno) in KMTL to Apraava, after obtaining the requisite regulatory and other approvals and compliance with conditions precedent.

The remaining 51% stake in KMTL will be transferred by the Company in accordance with the terms of the Transmission Service Agreement.
